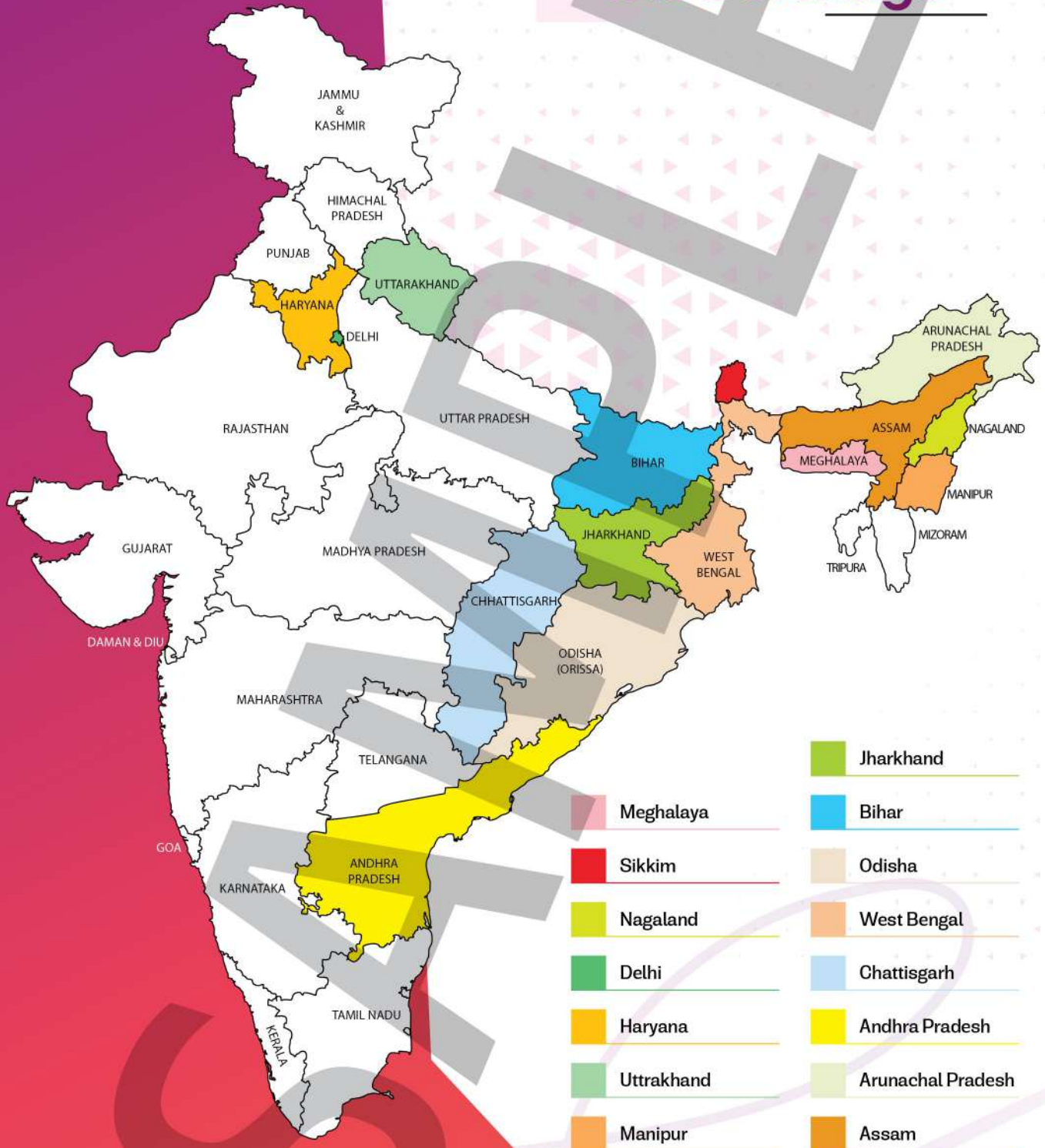

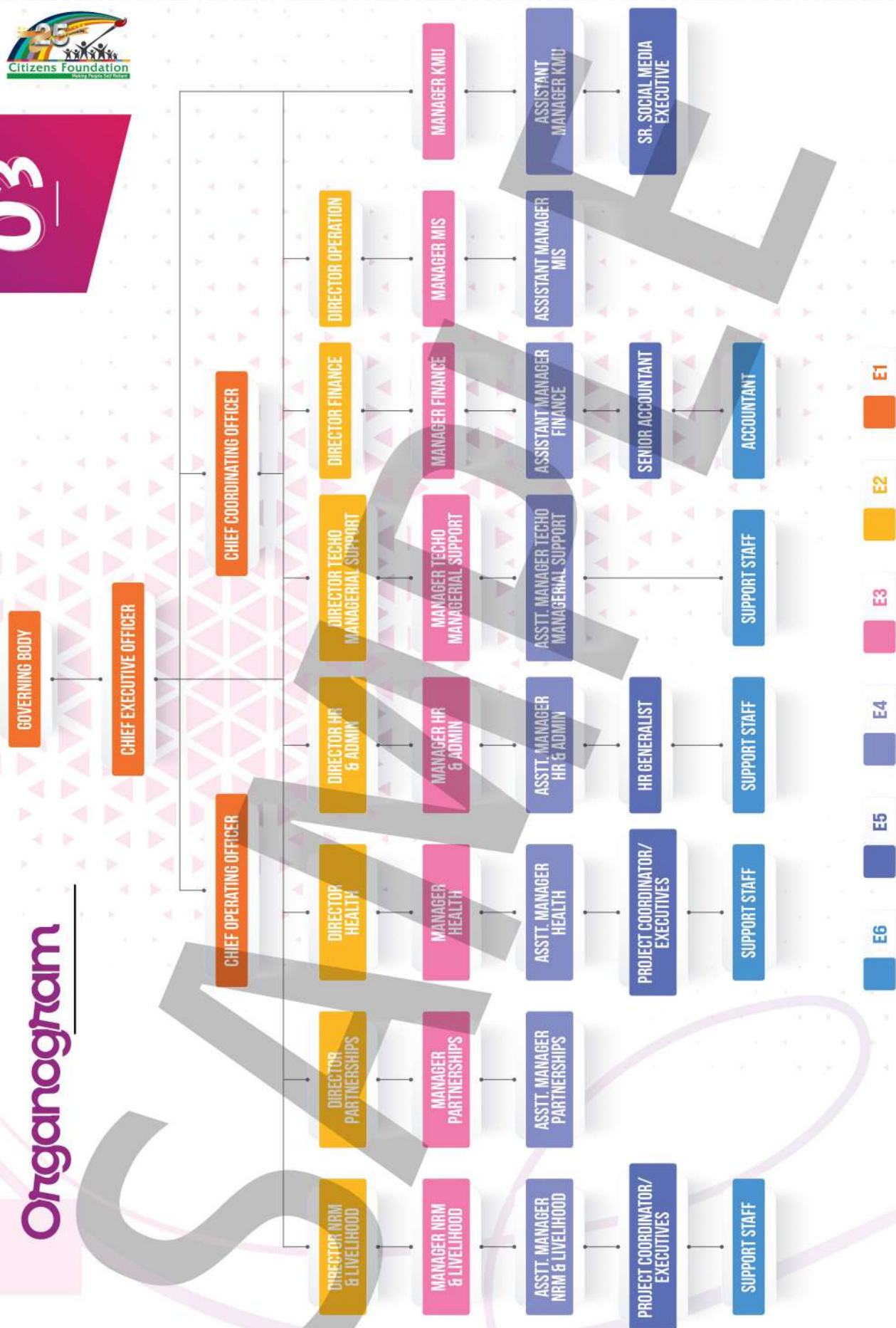

Primary Health Center, Jharkhand



Citizens Foundation and the Government of Jharkhand have come together in an inspiring public-private partnership, showcasing the profound impact such collaborations can have on community well-being. Through this initiative, eight revitalized Primary Health Centers (PHCs) now serve as pillars of health and hope in Bokaro (Kodia & Chatrochatti), Dhanbad (Chirkunda), Giridih (Mirzaganj), Jamtara (Gedia), Dumka (Baskuli), Saraikela (Haribhanja), and Lohardaga (Jowang). These centres deliver vital clinical care while actively engaging with the community through holistic outreach programs.

Developing 75 Anganwadi Centers and Up skilling Anganwadi workers



Citizens Foundation, in collaboration with the ONGC Foundation, has launched a transformative initiative to upgrade 75 Anganwadi Centers (AWCs) and enhance the skills of Anganwadi workers in Jharkhand, Nagaland, Assam, and Andhra Pradesh. This program focuses on fostering sustainable childhood care and improving nutritional support for children aged 0-6 years, as well as for pregnant and lactating women.



Key Objectives:

- ✓ **Upgrade Anganwadi Centers:** Modernizing infrastructure and resources across 75 centres to create a conducive environment for early childhood care.
- ✓ **Skill Enhancement for Workers:** Conducting training workshops and regular meetings to empower Anganwadi workers with the knowledge and tools needed for effective service delivery.
- ✓ **Nutrition and Health Awareness:** Educating communities on the importance of nutrition, health, and pre-school education for holistic child development.
- ✓ **Health Service Dissemination:** Organizing training sessions to share critical health service information with workers and communities.
- ✓ **Kitchen Gardens:** Establishing gardens at the centres to provide fresh, nutrient-rich food, particularly for pregnant and lactating mothers, addressing nutritional gaps sustainably.

This initiative aims to create a lasting impact by combining capacity building with community-driven nutritional solutions, ensuring the well-being and development of children and mothers across these regions.

Aarogya Project, Bokaro



Citizens Foundation, in partnership with ESL Vedanta, is working to improve healthcare access for rural marginalized communities in the Chas and Chandankiyari blocks of Bokaro through the Integrated Interventions and Resource Centre. This collaboration is part of the AAROGYA project, which focuses on tackling health challenges by managing health centres and fostering cooperation among departments and stakeholders.

A key aspect of the initiative is equipping health facilities with the capability to screen for diseases within the community and address health concerns effectively. This is bolstered by the deployment of Medical Mobile Units, which extend healthcare services to remote areas, ensuring broader coverage and accessibility.

In addition to providing direct health interventions, the project emphasizes raising awareness about preventable health issues, empowering communities with knowledge to make informed decisions about their well-being. It also aims to build capacity at every societal level, enabling communities to assess, analyze, and implement solutions for their health needs through active participation and genuine engagement. This holistic approach strengthens both the healthcare infrastructure and the community's role in fostering sustainable health outcomes.

Kalyan Hospitals, Jharkhand



KALYAN Hospitals in Jharkhand, run & managed by Citizens Foundation with support from the Tribal Welfare Department, are dedicated to delivering high-quality, compassionate healthcare to tribal communities. Initially launched as MESO Gramin Hospital, the facilities were rebranded as KALYAN Hospitals and began operations in Sahibganj, Pathna, in November 2018, and in Chaibasa, Barachiru, in December 2018.

These hospitals focus on addressing the healthcare challenges of economically disadvantaged tribal populations, particularly Primitive Tribal Groups. By offering top-tier medical services without financial burden, the initiative aims to bridge healthcare disparities and improve the well-being of marginalized communities.

KALYAN Hospitals are strategically evolving into resilient First Referral Units (FRUs), serving as critical healthcare hubs equipped to meet diverse medical needs. This transformation seeks to establish a robust network of primary healthcare providers, ensuring accessible and effective healthcare services for tribal populations across the state.

Mega Health Camp, Jharkhand



Citizens Foundation has partnered with RITES Ltd. to organize a series of free health camps across various villages in East Singhbhum, Jharkhand. Experienced medical professionals provided complimentary healthcare services, including checkups and medication distribution, to the villagers. The camps were staffed by specialists from renowned hospitals, covering a wide range of medical fields such as cardiology, pulmonology, gynecology, surgery, ophthalmology, general medicine, dentistry, and other specialties, serving the Jamshedpur area and its surroundings.





In addition to basic health screenings such as ECGs, X-rays, and blood pressure measurements, the health camps offered comprehensive full-body checkups utilizing advanced medical technology. This initiative aimed to increase healthcare access in remote areas.

For further treatment, patients will be referred under the Ayushman Bharat Scheme to hospitals such as Sanjivini Eye Hospital in Ulidih, where they will receive free surgeries. Additionally, individuals diagnosed with cardiac or urological conditions will receive free treatment at hospitals in Ranchi and Jamshedpur under the same scheme.

The MMU provides routine checkups, diagnoses, prescriptions, basic tests, and distributes emergency first-aid medicines to the patients in the vicinity of the PRPC.

Sanjeevani : Clinic on Wheels, Bihar

SBI FOUNDATION SBI Foundation in collaboration with Citizens Foundation launched the Sanjeevani - Clinic on Wheels program in August 2023. This is a community-centered initiative aiming to provide accessible healthcare services to underserved populations in selected villages. Through Mobile Medical Units (MMUs) and special camps, the program is addressing various health concerns prevalent in the community, including Non Communicable Diseases (NCDs) like hypertension and diabetes, reproductive issues in women, adolescent health, malnutrition, skin ailments, and geriatric care. Covering 20 villages, the project is conducting daily mobile health camps and quarterly special camps, ensuring regular access to healthcare services. These camps are held free of cost, making healthcare accessible to marginalized sections of society. The initiative is collaborating with stakeholders such as Gram Panchayat Institutions, Integrated Child Development Services (ICDS), Accredited Social Health Activists (ASHA), Auxiliary Nurse Midwives (ANM), Block Development Programs, and existing healthcare facilities like Sub-Centers and Public Health Centers. Key features of the project include mobilizing community members, cooperative action plan preparation, and fostering a sense of participation and collective effort to address local health concerns. By engaging stakeholders from various sectors, including ICDS, Health, Education, Panchayat, and Village Health, Nutrition, and Sanitation Committees (VHNSC), the initiative aims to ensure sustainable development and a lasting impact on the community. The primary outcome of the project is to improve access to healthcare services and enhance health outcomes for approximately 15,000 individuals in the targeted district. By bringing healthcare services directly to the doorstep of those in need, especially the poor, disabled, elderly, sick, and vulnerable, the initiative is striving to make a meaningful difference in the lives of community members.

INTEGRATED RURAL DEVELOPMENT



Integrated Rural Development

Citizens Foundation is dedicated to making a significant impact on the lives of underprivileged communities by focusing on poverty reduction and the alleviation of inequality. Our mission involves not only creating employment opportunities for impoverished households but also helping highly vulnerable households transition towards sustainable livelihoods and economic stability. Our efforts have reached diverse communities in regions like Jharkhand, Assam, Sikkim etc., each characterized by unique cultures, resources, and geographical challenges. They are particularly committed to contributing to the achievement of Sustainable Development Goals.

Holistic Rural Development Program (HRDP)

HDFC Bank's CSR partnered with Citizens Foundation to implement its CSR program, Parivartan, with the goal of fostering holistic rural development across 15 villages in Assam, 10 villages in Sikkim, and 15 panchayats in Arunachal Pradesh.

HRDP ASSAM

Citizens Foundation partnered with HDFC Bank CSR to launch the flagship "HRDP: Holistic Rural Development Program" in Assam, aimed at driving socio-economic progress for 4,127 underprivileged households. This initiative focused on 15 villages in the Kamrup (Rural) district and Tamulpur, specifically within the Goreswar and Bihdia Jajikona development blocks. The program seeks to empower these communities to foster sustainable development through collective action.



The selection of these villages was carefully carried out through a detailed assessment of their socio-economic conditions, geographical factors, accessibility, and population size. While the villages are spread across the district, they share common challenges, such as their proximity to wetland areas and susceptibility to flooding.

The Citizens Foundation's initiatives encompass diverse projects aimed at community development and empowerment.



HRDP SIKKIM

The project aims to accelerate the socio-economic development of at least 1,100 marginalized families, benefiting 4,499 individuals across 10 villages in the Pakyong Sub-District of East Sikkim. The goal is to enhance community-driven efforts for sustainable development, fostering a peaceful, prosperous, and egalitarian society within one year.

The project will be implemented in 10 villages within two different Gram Panchayat Units (GPUs) of the district: Amba GPU and Thekabong Parkha GPU. These villages were selected randomly, based on factors such as population, location, connectivity, and socio-economic conditions. The villages are strategically spread across the district, representing different vulnerable areas. This comprehensive initiative covers various sectors, including Livestock, Livelihood (both Farm and Non-Farm), Education, Health & Hygiene, Natural Resource Management & Clean Energy, and Financial Inclusion/Literacy.

SBI Gram Seva

Citizens Foundation has partnered with SBI Foundation to implement the Gram Seva Program in Bhojpur district of Bihar. The objective of the program is to have Integrated Rural Development of villages by adopting them and initiating interventions through major focus areas like Digitalization, Education, Health, WASH (Water, Sanitation & Hygiene), Skill & Livelihood Development, Women Empowerment, Youth Development, Community Engagement, Infrastructure and Environment. The program is being implemented for a period of 3 years. This partnership is for the adoption of 5 villages in Bhojpur District of Bihar.

Long term development of the identified village cluster, beyond the period of three years of the intervention, is one of the key objectives of the Gram Seva program of SBI Foundation. As part of this goal, capacity development of the Gram Panchayats/ local bodies forms a key element of SBI Gram Seva strategy. The ultimate objective is to ensure that after completion of 3 years, Gram Panchayats/ local bodies are in a position to proactively sustain and drive development of the villages.
