


EMPOWERING FUTURES:

CASE STUDY

Lighting Lives in Arunachal Pradesh

Overview:

In the rural village of Sagalee, Arunachal Pradesh, access to electricity is limited, posing challenges for students like 11-year-old Miss Nabam Ochu. Attending Ompuli School Sagalee Arunachal Pradesh, she faced difficulties studying after sunset due to the lack of lighting. However, her life took a positive turn when she received a solar lamp from the Citizens Foundation Supported by HDFC Bank Parivartan, enhancing her educational opportunities. Understanding the difficulties faced by students like Nabam Ochu, the Citizens Foundation initiated the distribution of solar lamps to schools like Ompuli, aiming to provide sustainable lighting solutions and improve educational access. Nabam Ochu received a solar lamp, enabling her to study after dark. The Citizens Foundation conducted training sessions on solar lamp usage and maintenance, empowering Nabam Ochu and her peers to utilize solar energy effectively. With the solar lamp, Nabam Ochu extended her study hours, enhancing her academic performance and confidence.

Nabam Ochu could study after sunset, leading to improved academic performance. With better visibility, Nabam Ochu excelled in her studies, earning recognition from teachers and peers and lastly the solar lamp empowered Nabam Ochu to pursue her educational aspirations with renewed Vigor.
