Mega Health Camp



Citizens Foundation collaborated with RITES Ltd. to host free health camps in different villages of East Singhbhum, Jharkhand. 11,656 Villagers were benefitted in 18 Mega Health Camps.

Experienced doctors provided complimentary health services such as checkups and medication distribution to the villagers. These services were delivered by specialists from renowned hospitals, covering various medical fields like cardiology, pulmonology, gynecology, surgery, ophthalmology, general medicine, dentistry, and other specialties in Jamshedpur and surrounding areas. The health camp not only offered basic checks like ECGs, X-rays, and blood pressure readings but also conducted comprehensive full-body checkups using advanced technology.



This initiative aimed to provide healthcare access to remote areas. Patients will receive further treatment under the Ayushman Scheme at hospitals like Sanjivini Eye Hospital in Ulidih, where they will undergo free surgeries. Additionally, individuals diagnosed with cardiac and urological conditions will receive free treatment at hospitals in Ranchi and Jamshedpur through the Ayushman Scheme.

HDFC PARIVARTAN

The HDFC Bank partnered with Citizens Foundation for implementation of its CSR Parivartan with the objective of holistic rural development of ten villages in Assam & Sikkim.



HRDP Assam

Citizens Foundation joined hands with HDFC Bank CSR to launch the flagship program "HRDP: Holistic Rural Development Program" in Assam. This project aimed to accelerate socio-economic progress for 1100 underprivileged families within a year. The initiative was focused on ten villages in Assam's Kamrup (Rural) district, specifically in the Hajo and Rangia development blocks, empowering these communities to initiate sustainable development through collective efforts.

The selection of the ten villages was meticulously based on a thorough assessment of their socio-economic status, geographic location, accessibility, and population size. Despite their dispersed locations in the district, these communities all share common characteristics such as proximity to wetland areas and vulnerability to flooding.

The Citizens Foundation's initiatives in Kamrup Rural encompass diverse projects aimed at community development and empowerment.

Installation of Solar Lights at Public Places :

This initiative addressed the lack of reliable electricity in Kamrup Rural, particularly benefiting villages prone to waterlogging. Solar street lights not only ensure safety for commuters, especially the fisherman community, but also promote the use of renewable energy sources, reducing dependence on traditional fuels.



Distribution of Solar Lamps :



In areas like Dihina, Assam, where electricity supply is irregular or absent, the distribution of solar lamps has significantly improved the lives of households, particularly children like Sumi, Shivani, and Nikumoni, enabling them to study and pursue their dreams despite challenges.

Holistic Rural Development Program :



Through initiatives like kitchen gardens, horticulture plots, oilseed cultivation, and solar irrigation, the Citizens Foundation fosters sustainable agricultural practices, empowers farmers economically, and ensures food security.



Education Infrastructure Renovation :

HRDP Sikkim

The project aims to accelerate socio economic growth of at least 1100 marginalized families, covering 4499 people across villages to enhance community action for initiating sustainable development process, and thereby create peaceful, prosperous and egalitarian society in 10 villages under Pakyong, East Sikkim district of Sikkim within one year.

The Project was proposed to be implemented in 10 villages, the details of which is mentioned below along with the Target beneficiaries. The Project was proposed to be implemented in ten villages under Pakyong Sub District of East Sikkim District of Sikkim. These are under two different GPUs of the same district namely Amba GPU and Thekabong Parkha GPU. All these villages were randomly selected, considering population, location, connectivity and socio-economic status. The villages are scattered in different directions of the district, representing different vulnerable areas of the district.

This extensive project encompasses various sectors like Livestock, Livelihood (Farm & Non-Farm), Education, Health & Hygiene, Natural Resource Management & Clean Energy, and Financial Inclusion/Literacy. Here's a condensed summary:

Livestock :

Implemented goat, poultry, and sheep rearing units, benefiting households with additional income and promoting pass-on concepts. Established dairy units with cows and calves, alongside vermicomposting units, contributing to waste utilization and holistic cow usage. Conducted veterinary camps, enhancing livestock health and productivity.



and market linkages. Implemented natural beekeeping, floriculture, and nutritional kitchen gardens, enhancing crop yields, biodiversity, and food security. Established RADi and tailoring units, empowering women and preserving local traditions.

Implementation of SCA to TSS and CCD Programme Mushroom Cultivation

Introduction:



Mushroom production is an important subject to Indian agricultural economy. Crop promoting and diversification is increasing employment opportunity. Mushroom has contains useful utility in reducing malnutrition and poverty. Apart from this, there is an important way to increase the income. In today's changing economic environment and economic security because its production is based on agriculture remedies, it does not required sunlight and soil .In this cultivation, need for small capital and land in addition. Mushroom cultivation, need for small capital and land in addition. Mushroom cultivation will improve our socio economic condition of our farmers, Youth, Especially women's and solve the unemployment problems of both literate and illiterate of the rural and semi urban area. After production of mushroom is goal manner convert into compost. In the past mushroom were often collected in forest and hilly area but today it is artificially made in more than 100 countries in the world including India. Various types of mushroom like button mushroom, Oyster Mushroom and Milky Mushroom etc milky mushroom etc. Are grown the level of business in India.



About the project:

This project is all about to identify to range of livelihood options persuade by the SHGs group with special references to Mushroom cultivation. Also improve agriculture technologies and practices to facilitation of market linkage for agricultural product.

Objective:

Objective of the project to improve the Socio-economic condition of the farmers and village community in the district of Dumka, Godda & Sahibganj of Jharkhand. The project enhances income generating activities which can be under taken by Scheduled Tribes (STs) poor farmers/SHGs (Female) with resources at command. The main objective of the project will be for farmers and SHG groups of the women to reach economic self-reliance as entrepreneurs through income generation. At the same time, we also aim double the income the farmers/SHG. The main objective of the exercise is to present a small scale viable bankable model production unit using modern technology.

Outcome and impact:

Beneficiaries were provided with 3 days training along with technical support, monitoring, counseling and exposure visit to mushroom farms. They learnt about the technique of mushroom production. All the necessary equipment including hand spray, mushroom bag, bamboo structure etc. were distributed for mushroom cultivation. They have been able to harvest two productions of mushroom



with over 100 kg productions and sold the mushroom in the local market and earned approximately Rs 5,000 with only two productions. Women Entrepreneurs are now continuing with the production with acquired skills and resources and is planning to expand the production with their income. The intervention is directly contributing to income generation of 500+ women and all the potential women of 6 villages. These women are now recognized as entrepreneurs who are now selling value added products and earning a better income.

These strategic interventions aim to enhance water retention, minimize runoff, and promote efficient utilization of water resources. Through these endeavors, Citizens Foundation contributes significantly to sustainable agricultural practices and ensures the long-term availability of water for communities in 14 Villages of Albert Ekka Jari block in Gumla.

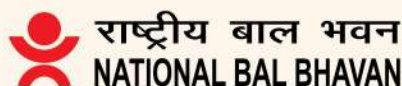
