PROMOTING RURAL HEALTH THROUGH EARLY DETECTION!

Citizens Foundation, with LTIMindtree, screened 1,540 villagers for anemia, hypertension

& BP across villages in Khunti, Jharkhand under IVDP.



Citizens Foundation, in collaboration with LTIMindtree, successfully conducted a Health Screening Camp in the villages of Cherwadag, Garke, and Kuda under the

Integrated Village Development Program (IVDP). The initiative focused on early detection and raising awareness about rural health issues. A total of 1,540 villagers were screened for anemia, hypertension, and blood pressure-related conditions. This effort marks a significant step toward improving community health by addressing common but often overlooked conditions through timely intervention and awareness. The camp also educated villagers on preventive healthcare practices, reinforcing the importance of regular health checkups in rural areas.

TRANSFORMING RURAL EDUCATION:

Inauguration of Renovated School & Smart Classroom at Sagalee, Arunachal Pradesh.



A proud moment for Sagalee as the renovated school building and a new smart classroom were inaugurated, supported by HDFC Parivartan and Citizens Foundation to promote rural education through better infrastructure and digital innovation. and Adv. Nabam Tatum Hina (OSD to HMLA 15th Sagalee), the event highlighted the importance of digital learning in bridging gaps in remote areas and the collective commitment to quality education for all.









BUILDING SELF-RELIANT COMMUNITIES IN ARUNACHAL PRADESH



Team Citizens Foundation undertook a two-day field visit to Sagalee, Arunachal Pradesh, under the HRDP project supported by HDFC Bank CSR Parivartan. The visit showcased remarkable progress across livelihood and infrastructure initiatives-from incense stick and orange processing units to poly houses, piggery farms, Farmer Producer Companies (FPCs), and health centers. Engaging directly with beneficiaries, the team

witnessed strong community ownership and an encouraging demand for further capacity building and exposure opportunities.









STRENGTHENING LIVELIHOODS IN SIKKIM::

High-yielding cardamom saplings + training for progressive farmers.



Citizens Foundation, under the HRDP-SIMANA Project in Sikkim supported by HDFC Bank Parivartan, has successfully carried out a cardamom sapling distribution initiative aimed at strengthening livelihoods in rural communities. The program reached 10 villages in Pakyong, where a total of 16,000 high-yielding cardamom saplings, including 800 vendor- contributed extras, were distributed to local farmers. In this initiative, 76

progressive farmers were each provided with 200 saplings, ensuring an equitable and impactful reach. Beyond distribution, the farmers are being supported with quality agricultural inputs, hands-on training, and pest control assistance. This holistic approach is designed to improve productivity, sustainability, and long-term income security for farming households.











SUSTAINABLE FARMING INTERVENTIONS **FOR FLOOD-PRONE REGIONS:**

Integrated Agri Farm-Mandia, Barpeta, Assam

Overview:

Jadabpur village, located in Mandia district, Assam, Faces a challenge of flood submerged fields affecting 37.4 acres of farm land for about 50 farmers, threatening their livelihoods. In response, the Citizens Foundation and LTIMindtree Foundation launched the Integrated Village Development Program, Initiating the Integrated Agri Farm at Jadabpur . With the High Yielding Variety of crop support, a floating duck farm was introduced for the first time, made of plastic drum to make it float and easy to move during flood, providing ducklings and finger lings as an alternate livelihood option for farmers, during those months. Additionally, vermin compost unit were also established to promote organic farming practices and to minimize the cost.





Challenges:

The primary challenge faced by the community was the frequent submergence of farm lands due to floods, impacting approximately 37.4 acres and affecting nearly 50 farmers. These floods not only damaged crops but also severely threatened the livelihoods of smallholder farmers, pushing many towards seasonal migration in search of alternative income sources. The lack of flood-resilient livelihood options and sustainable farming practices compounded the economic vulnerabilities of the villagers.

Impact:

The Integrated Agri-Farm initiative has significantly improved the livelihood and resilience of the local farming community. In just one cycle, over 300 ducks raised in floating sheds generated earnings of more than ₹ 1.5 lakhs for participating farmers. Encouraged by this success preparations for the next batch are underway, with income expected to increase by 30-40%. The integrated duck-cum-fish farming system has also enhanced fishery yields, with average house hold incomes projected to double from ₹ 8,000 to ₹ 16,000 due to the increased attraction of wild fish. Furthermore, the adoption of high-yielding paddy varieties and organic inputs has improved market rates from ₹1,200-1,500 to ₹1,400-2,000 per quintal, leading to a 15-25% rise in farm incomes. Collectively, these outcomes have helped reduce seasonal migration and laid the groundwork for a more sustainable, self-reliant rural economy.

This initiative stands as a replicable model of how community-led, climate-smart interventions can convert adversity into opportunity and promote inclusive rural development.
